RECITALS

WHEREAS, Infinity is a vendor of cameras and DVR products;

WHEREAS, _____ is the owner and principal of _____ ("Company");

WHEREAS, as a condition for continuing to do business with Company, Infinity requires that Guarantor unconditionally guarantee all present and future obligations of Company to Infinity; and

WHEREAS, Guarantor believes that it is in Guarantor's best interest to provide the requested Guaranty and has voluntarily agreed to execute this Guaranty;

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are acknowledged by Guarantor, Guarantor agrees as follows:

The obligations of the Guarantor shall not be diminished or discharged by any delay or extension of time that may be granted by Infinity, by any course of dealing between Infinity and the Company, by the release of any other obligor or any collateral, or by any other act, omission, or circumstance. Specifically and without in any way narrowing the scope of the foregoing waivers, the Guarantor waives any and all rights of notice, demand, presentation, subrogation, reimbursement, indemnification, contribution, election of remedies, and other rights and defenses that are or may become available to Guarantor by reason of California Civil Code §§ 2787 to 2855, 2899, and/or 3433, the California Commercial Code, or other statutory or decisional law.
